

# HAPŪ KARANGA FUND CRITERIA

## THE HAPŪ KARANGA FUND

The Ngāti Kahungunu ki Wairarapa Iwi Development Trust has established the Hapū Karanga Fund as part of its commitments to supporting the growth of Wairarapa hapū.

The total value of the fund is \$40,000. Each hapū karanga will be eligible to apply for up to \$5,000 per annum to deliver kaupapa aligned to Te Pātaka o Rongokako and its respective pou, Pou Tikanga, Pou Tāhua, Pou Taiao and Pou Tangata.

## STRATEGIC ALIGNMENT

We have four strategic pou: Tikanga, Tahua, Taiao, Tangata.

Under our Pou Tikanga, enabling our marae and hapū to strengthen Kahungunutanga for our uri whakatipu is one of our key values, Our vision speaking to whānau and hapū thriving.

## PURPOSE OF THE HAPŪ KARANGA FUND

The purpose of the Hapū Karanga Fund is to enable hapū and marae to lead and strengthen Kahungunutanga and support intergenerational transmission of mātauranga Māori.

## WHO CAN APPLY FOR HAPŪ KARANGA FUNDING

This fund is open to Wairarapa hapū karanga listed below:

- Ngāti Hinewaka Hapū Karanga
- Ngāi Tūmapūhia-ā-Rangi Hapū Karanga
- Te Hika a Pāpāuma ki Whakataki Marae Hapū Karanga
- Papawai Marae Hapū Karanga
- Te Ore Ore Marae Hapū Karanga
- Wairarapa Moana Hapū Karanga

Should multiple applicants within one hapū karanga seek funding support, applications will be sent to the respective hapū karanga representative for direction.

## WHAT CAN THE FUNDING BE USED FOR?

The Hapū Karanga Fund can be used to support:

- marae-based events

- wānanga
- tikanga and cultural kaupapa
- whānau engagement activities
- intergenerational transmission of mātauranga Māori
- kaupapa that strengthen Kahungunutanga

## DELIVERABLES

Hapū Karanga Fund applicants will be required to note the following:

### 1. Hapū Karanga Fund delivery plan:

- kaupapa that funds will support
- alignment to pou
- expected reach of delivery
- expected timeframe of delivery

Please provide the following supporting information alongside your funding application:

- Documentation confirming legal status of entity (e.g. Proof of incorporation under Te Ture Whenua Māori Act 1993 / Māori Land Act 1993 or other document)
- GST number if registered
- An invoice
- Bank verified account details (for the account to which the funding application will be paid)
