UPDATE ON SETTLEMENT

Tēnā koutou katoa

We're entering an exciting time for our iwi as we near the end of our Treaty of Waitangi settlement journey.

While it is not yet confirmed, we're expecting to initial our Deed of Settlement in December. As you know there have been some delays to our settlement. We're one of a number of iwi in a similar position because of Crown resourcing issues. Once the new Government has confirmed its plans we will share an update on timing.

The offer from the Crown of \$93 million

plus cultural redress and rentals from Ngāumu Forest means ours will be one of the largest settlements to date.

Our role as Trustees is to get the best settlement we can. We are almost done and if our lwi members accept the settlement it will bring an end to over 30 years of struggle and mahi. Our tīpuna started this journey and we owe it to them to complete it.

If you're a shareholder of Wairarapa Moana Inc and have whakapapa to our rohe, you're entitled to be a part of the comprehensive settlement. If you whakapapa to Rangitāne and Ngāti Kahungunu ki Wairarapa Tāmaki Nui-a-Rua, then you get to be a part of two settlements.

This settlement is for our whānau, hapū and iwi, our mokopuna, and to acknowledge our tīpuna.

SUCCESS OF ARATOI NGĀTI KAHUNGUNU EXHIBITION

After two years of preparation, Aratoi Museum presented the largest exhibition of Ngāti Kahungunu taonga ever on display, and the exhibition was a great success. Curated by Haami Te Whaiti, Te Marae o Rongotaketake -Redressing our Kahungunu History, was a significant exhibition corresponding with the journey of our people and our Treaty settlement.

As part of this exhibition, a full education programme was undertaken with primary and secondary schools throughout the region. Around 3,000 students came through the exhibition.

Total visitor numbers for the exhibition were 18.000! Pai mahi!

The exhibition opened in April and closed in September this year.


