

TRUST BOARD UPDATE AND SUMMARY OF MINUTES - MAY 2017

The Board met on Monday 15 May 2017. Delays outside of the Trust's control have caused the initialling of the Deed of Settlement to be pushed out to July 2017 (subject to change). These delays are partly due to Crown cabinet meetings being rescheduled, the relocation of government offices due to the Kaikoura earthquake and ongoing negotiations to address the cultural redress package.

TRUST BOARD UPDATE AND SUMMARY OF MINUTES - APRIL 2017

The Board of Trustees held their first hui as Established Trustees of Ngati Kahungunu Ki Wairarapa Tamaki Nui a Rua Settlement Trust, on Tuesday 18 April 2017. The PSGE Trust Deed was ratified through the holding of 8 PSGE Roadshows last November 2016 with a majority vote of 91.6% (through membership voting at roadshows and online voting) and the document was duly signed/dated 30 March 2017.

The Opening/Blessing of Te Marae o Rongotaketake was well attended by 300+ claimant community and other Whanau who wished to share this historic day. The many beautiful taonga that fills the exhibition area have even more beautiful korero behind them and the presence of Ngati Kahungunu ki Wairarapa Tamaki Nui a Rua is felt strongly.

TRUST BOARD UPDATE AND SUMMARY OF MINUTES - MARCH 2017

The Board of Trustees met 13 March 2017. Delays have occurred beyond our control by the Crown which has meant further delays in meeting set deadlines and milestones.

Discussion was also around the upcoming opening/blessing of Te Marae o Rongotaketake - Redressing Our Kahungunu History which is proudly supported by the Trustees of Aratoi Art and History Museum, Masterton. This event is to take place Saturday 08 April 2017 at 5.30am.

TRUST BOARD UPDATE AND SUMMARY OF MINUTES - NOVEMBER 2016

November has been a very full-on extensive month for the Trustees / Negotiators of PSGE Ratification Hui and Elections of HK Trustee representatives for Papawai (1), Tamaki Nui a Rua (2), Hurunui O Rangi (1) and Te Ore Ore (1). Eight roadshows took place, the last being held in Masterton on Sunday 27 November 2016. On-line voting buttons were added to the Website giving members the ability and availability to cast their votes for both PSGE ratification and Election of HK Trustee Reps. Results of the PSGE ratification have been received and are pleasing. 92% voted to ratify the PSGE. Voting is still in session to fill the 5 positions for HK Trustee representatives. Results will be announced soon.

TRUST BOARD UPDATE AND SUMMARY OF MINUTES - OCTOBER 2016

The Board of Trustees met on 10 October 2016 to discuss further developments towards the PSGE Ratification Hui Roadshows and Elections due to take place. AGREEMENT IN PRINCIPLE HUI A IWI HELD SATURDAY 23 APRIL 2016

The Hui A Iwi was held last Saturday and the outcome is shown below:

Announcement of Result of Hui-a-Iwi to Ratify Agreement in Principle

On Saturday 23 April 2016 188 members of Ngāti Kahungunu ki Wairarapa Tamāki Nui-ā-Rua voted on the ratification of the Agreement in Principle at a Hui-a-Iwi and out of these, 87% voted yes to the question:

"Do you accept the proposed AIP package and agree that the Trustees of the NKKWTNAR Trust sign the Agreement in Principle on behalf of NKKWTNAR?"

The Trustees and the Minister for Treaty of Waitangi Negotiations, the Hon Christopher Finlayson, will now sign the Agreement in Principle at Dannevirke Town Hall on 7 May 2016.

All members of Ngāti Kahungunu ki Wairarapa Tamāki Nui-ā-Rua are invited to attend the signing. Members of Ngāti Kahungunu ki Wairarapa Tamāki Nui-ā-Rua who wish to sign the Agreement in Principle in support of the settlement can also do so on the day.

TRUST BOARD UPDATE AND SUMMARY OF MINUTES - FEB 2016

The Board of Trustees met on Monday 15 February 2016 to discuss the progress of the negotiations and where they are at now. Further hui between February and beginning of March 2016 were held and it was decided that the Trustee reps for respective hapu karanga would present and discuss the Crown offer and the Agreement in Principle. This presentation contains: Summary of Agreement In Principle March 2016, Power Point presentation (Maps) and a PSGE Structure (Deloitte).

There will be numerous hapu karanga hui to be held.. Please note some hui have already taken place and were advertised on the Trust Facebook Page as well as Newspapers. Some are still taking place as listed for March/April 2016.

TRUST BOARD UPDATE AND SUMMARY OF MINUTES - JANUARY 2016

Following the AGM on the 19th of December there were no Trust Board meetings in January 2016.

Whanau will be aware that at the AGM the Trustees announced the next settlement offer from the Crown, and outlined next action. These actions include writing and meeting with officials and the Minister for Treaty Settlements, Chris Finlayson, to improve the offer that has been made.

In January this correspondence was dispatched, replies received, and meetings held. The meeting with Minister Finlayson was set for 1 February. This has meant delaying the proposed board meeting from that date until 15 February. It is expected by that on the 15th of February the Trustees will be able to consider the final offering being made by the Crown.

As announced that the AGM, once the offer is clarified further by the Crown, the wananga are to be held with the wider claimant community to discuss the full settlement package. This will be followed by a ratification (voting) process. Dates are expected to be set for these activities on 15 February.

TRUST BOARD UPDATE AND SUMMARY OF MINUTES - DECEMBER 2015

The Trustees met on 7 December 2015.

There were three main items of business:

- · PSGE development;
- Whakapapa Committee Update; and
- Management and Operational Matters.

In regards to the PSGE, the trustees discussed the breadth of proposed goals, and the need to ensure that promoting Te Reo Maori was an explicit objective of the new entity. The Trustees then discussed the need to ensure the PSGE was focused from the outset on ensuring marae were restored and maintained, and that funding would be available for this. Trustees also discussed, and agreed, that the PSGE would need to ensure whanau with particular connections with whenua that might be returned through the settlement process had an opportunity to be involved as Kaitiaki. In these areas resolutions to further develop the PSGE Deed were made. Following this, the Trustees also agreed further expert peer-review of the draft PSGE Deed was required.

The second item was the Whakapapa Committee report to the Trustees on enrolments. Overall steady registration progress is being made.

The third item was management and operations. Will Workman provided the monthly financial update, and outlined next steps in regards to accessing further funding from the Crown Forestry Rental Trust. The Trustees also took some time to discuss Will's role and next steps for operations of the Trust (Note as per conflict of interest protocol...
