

# TE PĀ ORA FUNDING CRITERIA

## PURPOSE OF TE PĀ ORA FUND

The Ngāti Kahungunu ki Wairarapa Tāmaki-nui-a-Rua Settlement Trust has established Te Pā Ora Fund as part of its commitment towards supporting the restoration, maintenance, and development of Ngāti Kahungunu ki Wairarapa Tāmaki-nui-a-Rua Marae.

Te Pā Ora has an annual allocation of \$150,000 to be distributed across 15 marae to support ongoing operational or running costs.

The Ngāti Kahungunu ki Wairarapa Iwi Development Trust and the Ngāti Kahungunu ki Tāmaki-nui-a-Rua Iwi Development Trust are responsible for administering Te Pā Ora funding.

## STRATEGIC ALIGNMENT

We have four strategic pou: Tikanga, Tahua, Taiao, Tangata.

Under our Pou Tikanga, enabling our marae and hapū to strengthen Kahungunutanga for our uri whakatipu is one of our key values, with one of our priorities being Marae Development.

## WHO CAN APPLY FOR TE PĀ ORA FUNDING

There are 15 Marae who can apply for Te Pā Ora funding:

For Marae that don't have physical buildings on their whenua, the Ngāti Kahungunu ki Wairarapa Iwi Development Trust and Ngāti Kahungunu ki Tāmaki-nui-a-Rua Iwi Development Trust can provide non-financial support to achieve their aspirations for their Marae through He Kawenata Hou relationships.



## WHAT CAN THE FUNDING BE USED FOR?

Funding applications will be considered for things that support the operational or running costs of the Marae. Examples include (but are not limited to): insurance costs, utilities (e.g., power or gas charges).

Te Pā Ora funding is currently not for capital or structural projects. However, if one of our eligible Marae does submit an application for a capital or structural project, we will require confirmation that the Marae:

- has sufficient cover to support their operational and running costs, and
- can confirm that they already have secured majority of the funding required for the capital or structural project, and the funding from Te Pā Ora will be to cover the remaining balance needed to complete the project.

## WHEN CAN MARAE APPLY FOR FUNDING?

We will notify marae once the funding round is open. The 2026 funding round will close 30 April 2026.
